**SLOPES: Storm and lightning damage last weekend in Perisher Valley**

Dear SLOPES Members

We are informed that lightning strikes last weekend in Perisher Valley have caused damage to a number of lodges.

The email below from JLT was sent to all clubs that are insured through the program that JLT administers for SLOPES Clubs.

About 20 Clubs are not on that program and so this email is issued particularly for their information.

As best we know at this stage:

1. according to the Bureau of Meteorology there were over 20,000 lightning strikes just on the Saturday, and the Friday storm was apparently worse
2. damage was confined to Perisher. Lodges in Guthega and Smiggins apparently were not affected.
3. affected lodges had their fire panels blown out along with other electrical appliances and equipment
4. one of the fire protection contractors used by many of our Clubs, Highlander Combined Services, has had it's people inspecting the lodges it looks after. If your Club uses Highlander you can expect to hear from them if there has been any damage.
5. JLT understands other contractors used by Clubs are doing the same as Highlander but we have not had this confirmed as yet.

If this is news to your Club, we suggest you investigate as soon as possible the position regarding your lodge.

For ease of claim notification and lodgement, I have attached a property claim form for completion and return.

You are required to minimise the loss as much as possible and any emergency repairs such as safety, security, fire protection/fire panel repairs are required to be done as soon as reasonably possible.

Where there is visible damage, please take photos and forward to me with your claim form along with all repair quotes/invoices.

Please ask the repairers to provide you with a written report stating what the cause of the damage/loss is.

Please note that our office phones are currently down because of the storm, however I am available on email or mobile should you need any assistance.
