This email updates you on the following:

**1. Membership Renewal**

Annual subscriptions for 2018/19 are now due for payment.

Your Club's invoice is attached.

Please renew your membership as soon as possible.

Payment options are detailed in the attachment.

It is important to clearly identify your Club's name if depositing to the SLOPES account at a local Westpac branch or if making the payment by EFT.

**2. Membership Renewal - no increase and comments on our reserves****This year we have not increased our annual subscription - it remains at \$275.**

SLOPES aims always to have in reserve a sufficient amount to take any major action, including engaging consultants or professional advisers, needed to protect or promote the interests of our Members.

This has been invaluable in the past in allowing us to make an immediate commitment on a legal process or major negotiation, as we have in recent years with important issues of concern to Members.

This year your subscriptions have covered our running expenses and added to our reserves.

Audited accounts will be available for the AGM in November as usual.

The Governance Review and the Capacity Review have concluded.

But we are still hopeful of new governance arrangements for the Perisher Range Resorts.

And there could be a major IPART review into Perisher Range Resort future costs and revenues (the current 10 year plan period having expired).

These will be MAJOR matters affecting all Clubs as foreshadowed in earlier emails.

SLOPES will monitor closely these matters on behalf of all Members.

We have assessed our reserves position in the light of this program.

We are also aware of the financial pressures on Clubs and the desirability of minimising membership fees wherever possible.

We expect our current reserves to be sufficient to cover expenses on the above major issues, at least for FY 18/19.

Accordingly, we have decided not to increase the renewal fee this year.

**We emphasise again that our strength through SLOPES lies in our 100% membership.**

This is absolutely critical to our ability to negotiate effectively with other parties.

Please help to maintain this situation by renewing your membership as soon as possible.

### **3. AGM Monday 19 November 2018**

We will be holding our AGM this year at the Chatswood RSL Club, 446 Victoria Avenue, Chatswood from 7.30pm on Monday November 19.

Please diarise the date and encourage your members to come along as we have arranged speakers from Perisher, NPWS and the Department of Planning covering topics of interest to all Clubs.

You will receive formal notice and details of the AGM closer to the date.

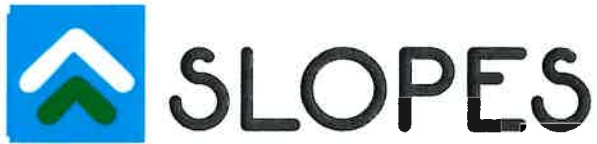
