This email from the Office of Environment & Heritage (OEH) is forwarded for your information.

In the email OEH announces:

- 1. proposed amendments to the Kosciuszko National Park (KNP) Plan of Management for public exposure and comment, and releases supporting and background papers
- 2. a Kosciuszko summit precinct walking tracks strategy covering existing pathways and a proposed Snowies Iconic Walk linking the ski areas of Perisher, Thredbo, Charlottes pass and Guthega. Some existing tracks would be subsumed into the walk augmented by new formed tracks to comprise a staged multiday trek or individual day hikes in either direction.

3. A range of visitor experience improvements (within the KNP) containing new, supporting and enabling provisions.

4. The draft amendments to the existing KNP Plan of Management.

SLOPES supports and encourages these proposals in principle.

We have yet to take a position on all elements proposed and some are outside the SLOPES sphere of interest or in other parts of the Park.

We support the idea of an iconic walk and look forward to reviewing its proposed route when released.

Walking or hiking is the major summer sporting activity within the KNP. Clubs and all Perisher Range Resorts stakeholders would benefit from new and improved pathways and alternative, expanded and upgraded local and over the hill hiking access. They are certain to encourage more summer visitors of Club members and friends. They will promote the sport for health and recreation and assist non profit sporting Clubs' in complying with income tax exemption rules.

SLOPES recognises that a walking trail linking the resorts would also be a springboard to access side trips to iconic panoramic mountains and valleys and special locations of interest.

In time the new and improved pathways will increase demand for hospitality services in our precinct and beyond from which all stakeholders and visitors will benefit as well as a greater opportunity to experience Australia's unique alpine country.

We encourage Clubs to distribute these papers to your members. They also explain how you and your members can have a say - note the submissions closing date is 11 March 2019.

The indicative location of the iconic walk is shown on the attached plan.

Investigation of suitable terrain for the pathway by OEH continues. Note:

- All new tracks to be predominantly constructed of elevated platforms and stone. This will minimise the environmental impact and will reduce the long-term maintenance costs
- Realignment of the existing Main Range Walk with an elevated platform of approximately 1,5km in length near Mt Lee. The track will be relocated slightly to the west to mitigate the existing impact to the critically endangered Windswept Feldmark plant community
- Construction of a permanent single toilet facility which will be positioned approximately 30m behind Seamans Hut. This will reduce the impacts of people camping near the hut. The toilet will be opened year-round
- It is expected the walk will use the following existing tracks (the exact location of the route is subject to environmental assessment and targeted species surveys):
 - Kosciuszko Walk (steel walkway) from Eagles Nest
 - Summit Walk to the top of Mt Kosciuszko
 - Main Range Walk from Kosciuszko to Charlotte Pass
 - The Illawong Walk from Illawong Hut to Guthega
 - The Porcupine Walk from Porcupine Rocks to Perisher Valley

The park is located in the NSW Snowy Region and is managed by NSW National Parks and Wildlife Service (NPWS), part of Office of Environment and Heritage.

use of the Thredbo Ranger Station, and some minor management and visitor improvements.

The Kosciuszko Summit Precinct Walking Tracks Strategy has also been prepared as a requirement of the plan of management, to enable the development of new walking trails in the summit area of the park. The strategy is also available for public comment.
